**REGULATIONS** on the conduct of competitions -  
International Belt Wrestling Tournament in Memory of the Great Tatar scientist,  
enlightener, Imam Shigabutdin Marjani (Match format)

**1. Venue and dates.**

Date of the event: May 30 - June 02, 2024

Location of the event: Russia, Republic of Tatarstan , Fatykha Amirkhana Street, 1 Г(G), Wrestling palace “Ak Bars”

**2. Goals and Objectives:**

- Enhancement of the spiritual, moral and physical development of youth ;
- Strengthening friendly and sporting relations among participants from different countries ;
- Promotion of belt wrestling among Muslim youth in the world.

**3. Organizers of the event :**

Ministry of Sports of the Republic of Tatarstan, International Federation of Belt Wrestling , Federation of Belt Wrestling of the Republic of Tatarstan , Spiritual Administration of Muslims of the Republic of Tatarstan.

**4. Event management:**

General management is carried out by organizing committee.

Direct management of the competition is entrusted to the Federation of Belt Wrestling of the Republic of Tatarstan and the main panel of judges.

**5. Competition conditions and admission of participants:**

Competitions are held in accordance with the current rules of the International Belt Wrestling Federation in accordance with the approved Regulations, in the format of match meetings "wall to wall" in the following weight categories:

- Men (freestyle): 57kg, 62kg, 68kg, 75kg, 82kg, 90kg, 100kg, 100+kg

The team consists of participants, 1 representative, 1 coach, 2 judges.

Mating in the weight category is not allowed.

Athletes aged 18 years and older are allowed to participate in the competition as part of the following teams:

- **national teams of countries** participants of which have the citizenship of their country and represent the interests of national belt wrestling federations;
- **national teams of the regions of the Russian Federation**, whose participants have a residence permit for the region they are representing;
- **national teams of continents** where participants from continental federations at the initial stage of development are eligible to participate.

Teams are allowed to compete only on the basis of an official written individual challenge from the International Belt Wrestling Federation.

Each delegation must submit to the organizing committee two national flags (120cm by 180cm) and CD/DVD with a recording of the national anthem (short version).

## **6. Determination of the team championship:**

The system of holding the team championship will be decided by the judging panel before the start of the competition, depending on the number of teams participating in the competition.

## **7. Insurance of participants of competitions:**

Insurance of participants of competitions is carried out by sending organizations.

## **8. Ensuring the safety of participants and spectators:**

Ensuring the safety of participants and spectators at sports competitions is carried out in accordance with the requirements of the Rules for Ensuring Safety during Official Sports Competitions approved by the Decree of the Government of the Russian Federation No. 353 of April 18, 2014.

The chief judge of competitions is obliged, in accordance with the Recommendations on ensuring safety and preventing injuries during physical culture and Sports (Appendix No. 1 to the order of the Committee of the Russian Federation on Physical Culture No. 44 of April 01, 1993):

- check the condition and readiness of the competition venue, inventory and equipment, premises for the secretariat, judges, make sure that there is an act on the suitability of the facility for holding sports and entertainment events, sign an Act on the readiness of the sports facility for holding this competition;
- start competitions only if there is a doctor on duty or a medical team on duty.;
- allow judges to work only after passing instructions on TB, fire safety from the Owner (user) of the sports facility with mandatory recording of the instructions in the relevant journals;
- allow athletes to compete only if they provide the credentials committee with the original agreement (insurance policy) on insurance of accidents, life and health.

**Owners (users) of sports facilities are responsible for timely notification to the supervisory authorities about the conduct of competitions and compliance with their requirements (the Ministry of Internal Affairs, Rosпотребнадзор, etc.)** ensure public order and public safety (it is mandatory to have a video surveillance system and technical equipment in accordance with the rules for ensuring security during official sports competitions in order to organize access and intra-object mode).

## **9. Financing:**

Expenses related to the competition are carried out with the participation of the International Belt Wrestling Federation, the Ministry of Sports of the Republic of Tatarstan, and the Spiritual Administration of Muslims of the Republic of Tatarstan.

## **10. Award process:**

According to the results of the competition, the teams that took 1-3 places are awarded with cups and diplomas of the corresponding degrees, participants in the team that took 1-3 places are awarded with medals and diplomas of the corresponding degrees, as well as valuable gifts from sponsors and other organizers of the competition.

## **11. Submission of applications for participation:**

A preliminary application containing information about athletes (including the referee, coach and representative) participating in international sports competitions is sent 10 days before the start of the competition to the organizing committee for the competition at the following addresses:

Applications certified by a doctor and the head of the executive authority in the field of physical culture and sports are submitted to the judging panel on the day of arrival.

The application must be accompanied by the following documents for each athlete::

- a copy of the athlete's passport or international passport;
- insurance contract (original).

Judges must have with them: a passport (international passport) and a judge's qualification book.

## **12. Terms of summing up the results:**

To the Chief Judge within 3 days from the date of the end of the competition, you must submit to the International Belt Wrestling Federation:

1. Approved competition protocols on paper and electronic media.
2. Written report on the competitions held and on the rating of judges serving these competitions.
