Competition REGULATIONS World Belt Wrestling Championship

WORLD BELT WRESTLING CHAMPIONSHIP

1. General provisions.

1.1. The World Belt Wrestling Championship is held to achieve the following goals:

- popularization and development of belt wrestling in the world;
- strengthening and developing international humanitarian and sports ties and intercultural exchange between the peoples of different countries.

2. Rights and obligations of organizers of sports competitions.

2.1. The Ministry of Sports of the Republic of Tatarstan and the IFBP determine the conditions for conducting sports competitions provided for in these regulations.

2.2. Distribution of other rights and obligations, including liability for harm caused to participants of the event and /or third parties, is carried out on the basis of an agreement between the IFBP, the FSNP of the Republic of Tatarstan and other organizers of sports competitions (with the exception of the Ministry of Sports of the Republic of Tatarstan) and / or in the regulations of a specific sports competition. If the distribution of these rights and obligations is carried out on the basis of a contract, the rules of a particular sports competition contain a reference to the details of such contract (number and date of conclusion of the contract).

3. Venue and dates of the event.

Venue: 1G Fatykh Amirkhan str., Ak Bars Martial Arts Palace, Kazan, Republic of Tatarstan, Russia

Dates: November 10-13, 2024

4. Competition organizers.

The management of the organization and holding of competitions is carried out by the International Belt Wrestling Federation, the All-Russian Belt Wrestling Federation, the Ministry of Sports of the Republic of Tatarstan, and the Belt Wrestling Federation of the Republic of Tatarstan.

5. Requirements for participants and conditions of their admission.

Athletes at least 18 years of age who have the citizenship of their country and represent the interests of national belt wrestling federations are allowed to participate in the World Championship.

Official composition of delegations from national belt wrestling federations to the World Championship:

Athletes-men (classic style) – 8 persons, men (freestyle) - 8 persons, women (freestyle) - 5 persons

Representatives-head – 1 person, coach 2 persons. Judges – 2 persons

Athletes from each country are allowed to compete, with two competitors in each weight category.

Financial expenses of participants of the second composition are carried out by the sending organizations.

Each delegation must provide the Organizing Committee with two national flags (120cm by 180cm) and a CD/DVD with the national anthem (short version).

6. Competition conditions.

The World Belt Wrestling Championship is held in freestyle and classic style, in accordance with the current international rules for judging belt wrestling, under the control of the judging panel of the International Belt Wrestling Federation in the following weight categories:

- men (freestyle): 57kg, 62kg, 68kg, 75kg, 82kg, 90kg, 100kg, 100+kg;
- men (classic style): 57kg, 62kg, 68kg, 75kg, 82kg, 90kg, 100kg, 100+kg;
- women (freestyle): 52kg, 58kg, 66kg, 76kg, 76+kg

In each weight category, 1, 2 and two 3 places are played.

7. Financing.

Expenses related to the competition are shared by the International Belt Wrestling Federation and the Ministry of Sports of the Republic of Tatarstan and are distributed according to additional written agreements of the parties.

8. Award ceremony.

Athletes who took 1st, 2nd and two 3rd places are awarded with medals and diplomas of the corresponding degrees. The coach of the champion is awarded with a diploma.

9. Ensuring the safety of participants and spectators.

The chief judge of the competition is obliged, in accordance with the Recommendations for ensuring safety and Preventing injuries during Physical Culture and Sports, to:

- check the condition and readiness of the competition venue, inventory and equipment, premises for the secretariat, judges, make sure that there is an act on the suitability of the facility for holding sports and entertainment events, sign an Act on the readiness of the sports facility for holding this competition;
- start competitions only if there is a doctor on duty or a medical team on duty;
- allow athletes to participate in competitions only if they provide the original contract (insurance policy) on accident, life and health insurance (athletes are insured by sending organizations).

Competitions are allowed to be held in sports facilities that have been put into operation by state commissions and subject to the availability of technical inspection certificates.

Owners (users) of sports facilities are responsible for timely notification to the supervisory authorities about the conduct of competitions and compliance with their requirements (the Ministry of Internal Affairs, Rospotrebnadzor, etc.), ensure public order and public safety (a video surveillance system and technical equipment are required in accordance with the safety rules for official sports competitions to organize access and intra-object mode).

The basis for admission of an athlete to sports competitions based on medical certificates is an application with the mark "Admitted" next to each athlete's surname with the signature of a physical therapy doctor or a sports medicine doctor and certified by a personal seal, if there is a signature with a transcript of the doctor's full name at the end of the application, certified by the seal of the medical organization that has a license to perform medical care activities, a list of works and services that includes physical therapy and sports medicine (a medical certificate of admission to competitions is possible, signed by a physical therapy doctor or a sports medicine doctor and certified with the seal of a medical organization that meets the above requirements).

Medical admission of participants to sports competitions is carried out not earlier than one month before participation in sports competitions.

Personal safety, including insurance, is the sole responsibility of the competitor. Each participant must have a health insurance policy and personal protective equipment. The organizing organization and the judging panel are not responsible for any physical damage to the competitor, for his life, damage to his property or loss of property during the competition.

10. Submission of applications for participation.

A preliminary application containing information about athletes (including the referee, coach and representative) participating in international sports competitions is sent 10 days before the start of the competition to the organizing committee for the competition:

Applications certified by a doctor and the head of the executive authority in the field of physical culture and sports are submitted to the judging panel on the day of arrival.

The application must be accompanied by the following documents for each athlete:

- a copy of the athlete's passport or international passport;
- insurance contract (original).

A judge must have a passport, INN, SNILS and a judge's qualification book.

11. Terms of summing up the results:

The Chief referee must provide the following information to the International Belt Wrestling Federation within 3 days of the end of the competition:

1. Approved competition protocols on paper and electronic media.
2. A written report on the competitions held and on the rating of the judges serving these competitions.

This provision is an official challenge to the competition
